Motion seconded. Jim called the Mumfords, spoke to Bill and asked them to bring checkbook to Door County so Bill Lux can be paid. Also advised Bill 7 members wanted to renew their membership tonight. (Dave & Sharon Morris, Bill Meadows, Tom & Patti Douglas, and Donna & Bill Lux) Bill said to have them bring the checks to Door County and Jean will do the paperwork there.

Bill Lux continued with his report covering AMA and reminding members that AMA dues are Due too. AMA should send you a notice.

Vice President Kevin Johnson

(Absent-out of State on Business) Jim Marsolais inform the club that over the Labor Day weekend while riding the Great River Road in Buffalo City Wisconsin, just after leaving the city with two cars in front that had to be going as fast if not faster than Kevin's motorcycle a Buffalo County Sheriff's Deputy opted to stop Kevin's Motorcycle (3rd Vehicle in the procession) and gave Kevin a \$175.00 citation for 65MPH in 55MPH zone. The Deputy explained that he stopped Kevin because all over Wisconsin on the Labor Day Weekend Police are targeting Motorcycles. The Deputy explained that this weekend so far they have only had two accidents as the result of their Motorcycle targeting campaign, so it

seemed to be working. Larry Haun added that Illinois State Police set up a Roadblock for Motorcycles only at the O'Hare Oasis. All motorcycles had to enter the Oasis and the Police checked for M Classification and for Insurance. Bill Lux believes AMA has had similar cases that they fought in Florida. A Motorcycle is a motor vehicle. If Police are going to run a roadblock, it has to be published before hand and they have to stop vehicles consistently. Police can't stop only cameros, or only cars with teenagers, or only people of a certain race, so Why can they target and stop only Bikers? If the Police stopped say every 6 vehicles or every 6th vehicle and a motorcycle was one of those six, that would be okay, but to let 40 – 50 vehicles (Cars & Trucks) pass, and then stop a motorcycle doesn't seem right. It will be interesting to see if the AMA Lawyers get involved. The same thing happened in Starved Rock earlier this year, only Motorcycles entering the park were stopped and checked for License, Insurance and Alcohol consumption.

called via telephone and reported that the club has aprox. \$1100.00 in the account. Additional monies obtained through DUES, selling patches and Mystery Raffle. DUES WERE DUE IN JUNE! 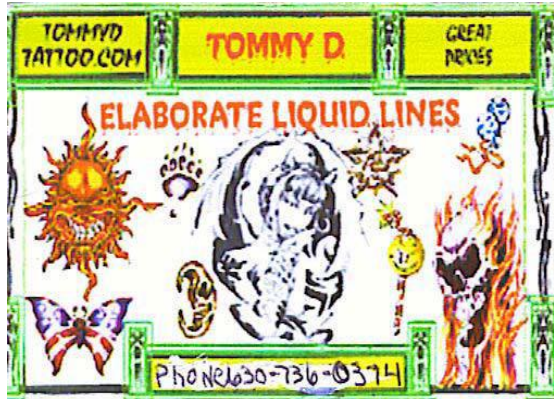

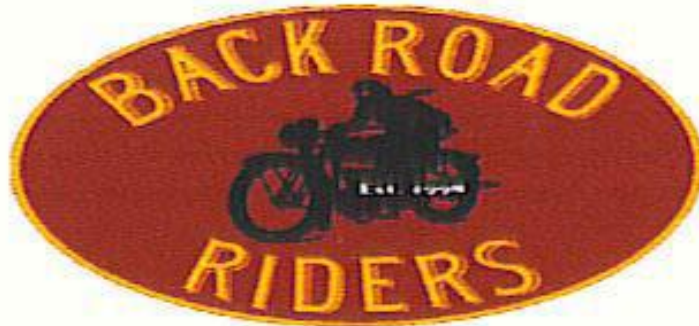
